Neither the Owner nor the management is responsible for the loss of personal belongings caused by fire, theft, smoke, water, or otherwise, unless caused by their negligence. Renter's insurance policies are strongly encouraged to cover such personal property.

The undersigned warrants and represents that all statements herein are true and agrees to execute a Fixed Term Lease or a Tenancy At Will agreement in the usual form, a copy of which the applicant has received or has had occasion to examine, which lease or agreement may be terminated by the Lessor if any statement herein made is not true. Deposits are to be applied as shown above, or applied to actual damages sustained by the Owner, except it is to be refunded if said application is not accepted by Owner. This application and deposit are taken subject to previous applications. **If an applicant withdraws from an apartment after being approved by Owner, his/her deposit will NOT BE REFUNDABLE.** The approval and acceptance of the application will be mutually agreed upon by deposit of the security deposit check. If application is denied, security deposit check will be returned within five (5) business days.

The renting agent is an independent contractor and has no authority to make any representation concerning the premises; the renting agent is only authorized to show the apartment for rent and to assist in the screening of the rental applicants.
